WORLD LANGUAGE AND EL EDUCATORS:

If you're looking to purchase Mango Classroom or other language-learning software, we have great news: The federal government offers a significant amount of funding opportunities. Many of these sources are part of the <u>Every Student Succeeds Act</u> (ESSA), formerly the Elementary and Secondary Education Act (ESEA). The goal of ESSA is to provide equal opportunities for all students and prepare them for postsecondary success.

Below is a guide to help you understand various funding sources and make the case for why your World Language or EL program qualifies for the funds to purchase digital language-learning tools, like Mango Classroom.

ESSER II (Elementary and Secondary School Emergency Relief) and ARP (American Rescue Plan) Funds

WHAT IT IS: The Coronavirus Response and Relief Supplemental Appropriations Act (ESSER II), and the American Rescue Plan Elementary and Secondary Emergency Relief Act (ARP ESSER) address the impact of COVID-19 on our nation's schools. They are provided as formula grants based on each state's share of Title I funds. Districts can use ESSER II funds for materials that address learning loss, assessments, technology, PD, summer school, and social-emotional learning programs.

TOTAL AMOUNT: \$67 billion

HOW MANGO QUALIFIES: Often surprising to world language leaders, ESSER funds can be used to support world language programs as well as ELs. Justifications for this funding include showing how an initiative supports the use of technology in the classroom and a well-rounded education. Therefore, digital World Language tools, such as Mango Languages, are a natural fit. Examples of initiatives include learning a new language, launching an exploratory language program, supporting growth in a heritage language, and/or helping students gain a well-rounded education.

Title I, Part A, Improving Basic Programs Operated by State and Local Educational Agencies



WHAT IT IS: For schools with high levels of poverty, these funds are earmarked for supplemental programs for at-risk students to ensure a well-rounded educational program. They can be used to hire additional teachers, launch intervention programs, purchase supplemental resources, etc.

TOTAL AMOUNT: \$20.5 billion in fiscal year 2023

HOW MANGO QUALIFIES: Mango Classroom qualifies as a supplemental resource by helping EL newcomers communicate confidently in the classroom and by enriching the education of at-risk students with World Language learning.

Title I, Part C: Migrant Education

WHAT IT IS: Funding for schools to establish and improve programs and services for migrant children to help overcome educational disruption.

TOTAL AMOUNT: \$375 million

Title II, Part A, Effective Instruction

Title IV, Part A, Student Support and Academic Enrichment Grants (SSAEG)

TOTAL AMOUNT: \$1.28 billion

Title IV, Part B, 21st Century Community Learning centers (CCLC)

Adult Education and Family Literacy Act (AEFLA)

TOTAL AMOUNT: \$668 million
